



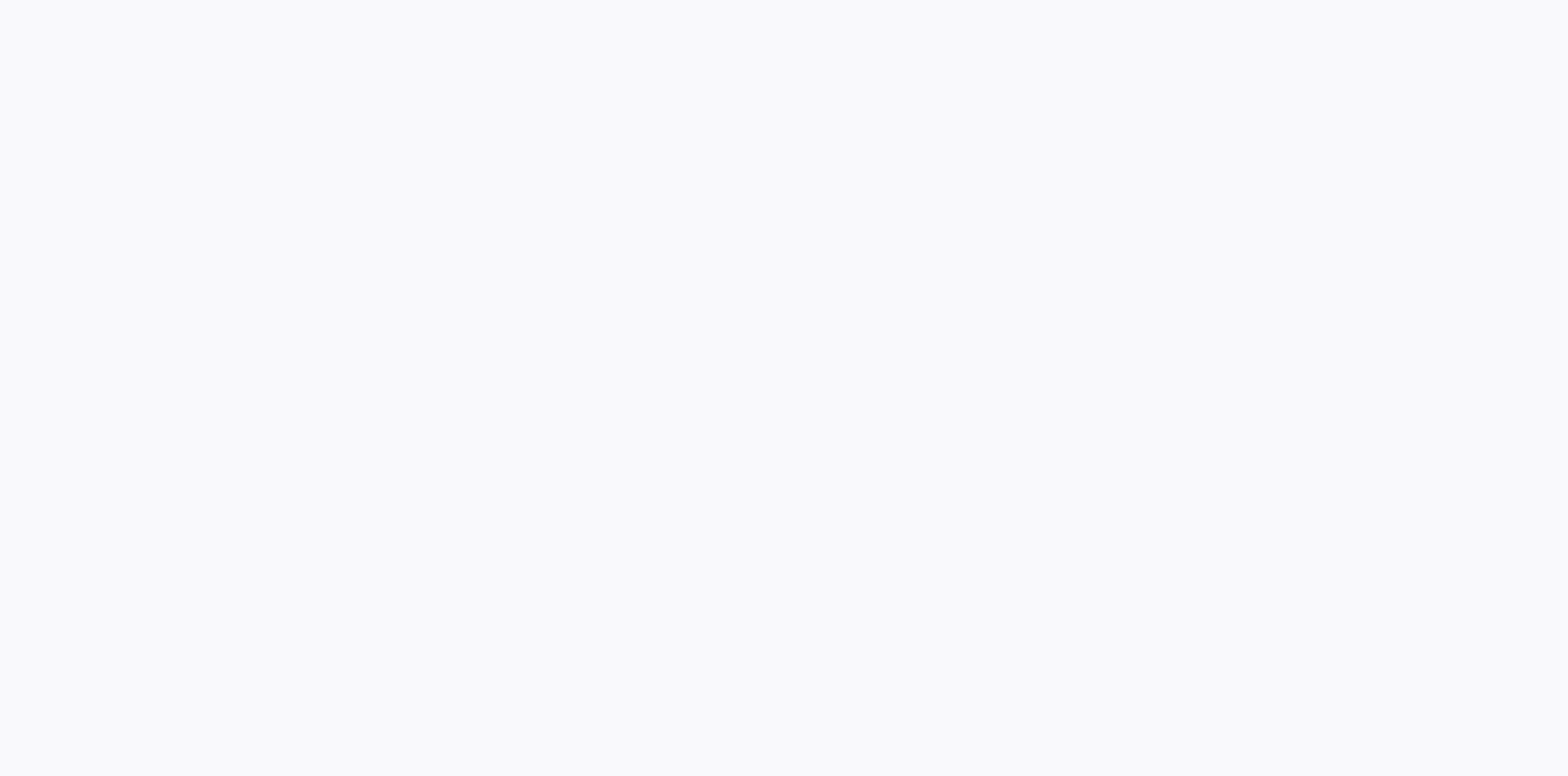

Although Vallejo argued that the name of the Narcos episode depicting this scene, “The Palace in Flames,” copied the title of the corresponding chapter in Vallejo’s memoir, the court rejected this argument on the basis that short phrases are not copyrightable. Vallejo additionally argued that the district court failed to recognize “the legal distinction between historical and non-historical facts in assessing whether the facts she reported in her memoir should be given copyright protection,” positing that “non-historical facts” are protected by copyright law “because they are personal.” The court, however, rejected this legal distinction, pointing to the Supreme Court’s decision in Feist Publications, Inc.
